Before You Visit a Depot

- Confirm hours of operation at your local <u>depot</u>.
- Empty and rinse containers, especially milk containers.
- · Leave tabs, labels, and lids on containers.
- If you pre-count your containers, it can help to make the process faster as depots confirm the count.
- Call ahead if you have a large volume of containers to return.

What Your Depot Can Do for You

- Commercial pickups for businesses that have a large volume of beverage containers (check with your local depot to see if they or a charitable partner offer a commercial pickup service).
- Help set up a donation program or bottle drive.
- May be able to provide recycling bins, door knockers, and additional support for bottle drives and other collection events.

Out-of-Province and Unregistered Containers

All depots are prohibited from accepting or providing a refund for:

- Beverage containers purchased outside of Alberta.
- Beverage containers not registered in Alberta.

Fines of up to \$50,000 (for an individual) or \$500,000 (for a corporation) can be issued for accepting or providing refunds for these containers.



Non-Refundable Containers

Some containers look similar to refundable beverage containers but are NOT regulated under the Beverage Container Recycling Regulation and therefore, not part of the deposit refund program. This means a depot cannot pay a refund for them. This includes, but is not limited to, containers for products like soup, broth, cooking oil, yogurt, some alcoholic shots, mini creamers, and concentrates.

What happens to recycled containers?

Recycled beverage containers are used in the manufacture of many commercially useful products:

Aluminum Cans

Plastic Containers

 new plastic containers or plastic products



Glass Containers

• fibreglass insulation



Refillable Glass Beer Containers

 can be reused up to 15 times



Polycoat, Juice and Milk Cartons

 paper pulp and cardboard



Bi-Metal Containers

 scrap metal for construction rebar



RETURN THESE CONTAINERS FOR A REFUND



Unsure if a container can be returned for a refund and recycled? Search for it in our beverage container registration database, which can be found in our beverage container registration portal by scanning the container bar code using the Alberta Depot app or under the under the *Selling a Beverage in Alberta* tab at <u>www.bcmb.ab.ca</u>.

✤ Both the cardboard container and bladder must be returned for a bag-in-a-box container to be eligible for a refund.
