**Data Collection Agent IR Response Extension Request**

Further to my letter dated December 3, 2025, I am writing to provide the ABDA's proposal in response to the DCA's request for an extension. The ABDA proposes the following:

- (a) As part of the DCA's preliminary responses on December 19, 2025, the DCA shall provide complete responses to each of the following ABDA information requests: ABDA-DCA-1(a)-(d) and (e)(i); ABDA-DCA-3(a), (b) and (f); ABDA-DCA-15(a), (c) and (e); ABDA-DCA-16(a), (c) and (d); and ABDA-DCA-25(a).
- (b) The deadline for the DCA's responses to information requests shall be set to January 7, 2026, as opposed to January 9, 2026.
- (c) The deadlines for schedule items #26-29 (item numbers as per the December 3 proposed schedule) shall each be adjusted forward by a further five days: written statements moved to January 28, 2026, DRP IRs to February 11, 2026, DRP IR responses to February 25, 2026, and rebuttal statements to March 18, 2026.
