

Registration Requirements

for Non-Alcoholic Beverage Containers



Introduction

The registration steps outlined in this document relate to **non-alcoholic**, non-refillable beverage containers.

All beverage containers containing **alcohol** must be in an approved container¹ (see the list of approved containers in the Beverage Container Registration Portal at http://portal.bcmb.ab.ca) and registered through the Alberta Gaming and Liquor Commission (AGLC). If your beverage container is **refillable**, please contact our Product Registration department directly before registering your container. They can be reached at 780-424-3193 ext. 221 or 224, or 1-888-424-7671 (toll-free) or by email at registrations@bcmb.ab.ca.

Please see the appendix on page 6, *Approved Non-Refillable Beverage Containers*, for information relating to the recyclability of containers. If a material is listed as not approved, **it cannot be registered** by AGLC or the BCMB.

¹The BCMB maintains a list of container codes for approved beverage containers. This ensures the materials used in the composition of the containers can be recycled and will not contaminate existing material streams. The composition of the container includes all components – including but not limited to the container, closure (lid), label and any other inserts or attachments. If you have questions about the list of approved containers, which can be found in the Registration Portal, please contact the BCMB.



In order to register your beverage container and be compliant with the <u>Beverage Container Recycling Regulation</u>, please ensure you complete the following steps. For detailed instructions, please see the <u>Beverage Container Registration Portal User Guide</u>.

STEP 1 CREATE A REGISTRANT ACCOUNT WITH THE BCMB

Your Registrant Account can be created through the Registration Portal at **http://portal.bcmb.ab.ca**. You will need to provide the following:

- Registrant Information
- Alberta Incorporation Documents
 - If your corporation was formed in another province or country, we require a copy of your <u>Extra-Provincial Incorporation/</u> Registration Documents
- A non-refundable, \$60.00 registration fee
 payable by cheque issued and mailed to the BCMB
- Confirmation from the Collection System Agent (CSA)

 Alberta Beverage Container Recycling Corporation
 (ABCRC) that a CSA Agreement has been completed and refundable deposit paid (see Step 2).

STEP 2 COMPLETE A CSA AGREEMENT WITH ABCRC²

ABCRC acts on the part of registrants to collect and process empty beverage containers and to reimburse bottle depots. The BCMB will not approve a Registrant until we receive confirmation from ABCRC that the CSA Agreement has been completed and the \$5,000 refundable deposit (or an amount based on your three-month sales forecast, whichever is greater) has been paid.

²The Beverage Container Recycling Regulation (BCRR) requires that manufacturers appoint, use and maintain a CSA to operate a common collection system. ABCRC will act, on the part of the registered manufacturer, to collect and process empty post-consumer beverage containers and to reimburse bottle depots as required under the BCRR.



STEP 3 REGISTER EACH BEVERAGE CONTAINER

Once your account has been created, you must register each beverage container you sell or distribute in Alberta (the individual container is registered, not multi-container packaging). To register your beverage container(s), you will need to provide the following:

- Container Information³
 - material composition including closure,
 label application and any other components)⁴
 - size
- Beverage Information
 - brand
 - flavour
 - UPC⁵
- Images of the container with the product label, displaying the brand, flavour, size, material and UPC.⁶
- Sales start date (if you are not sure when you will be launching the new beverage, please provide an estimated date and then advise the BCMB once the actual sales start date has been determined.

To start the registration process, please proceed to the Registrant Login at http://portal.bcmb.ab.ca to create a new account.

Once approved, all registered beverages containers will be listed in the searchable database on the BCMB's website at http://portal.bcmb.ab.ca/product.

³As per Section 16 of the BCRR, non-refillable containers are to be recycled by a method approved by the Board. Your beverage will need to be in an approved container prior to registration. Please see the appendix for a list of approved non-refillable beverage containers, label materials, closure materials and additional components. A list of approved containers and their codes can also be found in the registration database and portal.

⁴If a container is pre-existing, you will not be prompted for the material composition information.

⁵If a container does not have a UPC, the registrant is required to provide 360 degree images of the container (images from all angles). Upon verification, these beverage containers will be registered without a UPC.

⁶As per Section 6.1 of the BCRR, containers must be labelled in such a way that the type of beverage is easily identifiable (even when the container is empty) and it is clear the container can be returned for a refund of the deposit paid when purchased.
